Wick Golf Club Local Rules

Out of Bounds

The boundaries of the course are the fence behind the clubhouse continuing around the implements shed and on to practice area shown with white stakes. The fence on the left hand side of course going out and the river Wester.

Penalty Areas

The ditches running parallel to the boundary fence on left hand side of course going out are lateral penalty areas (red). The ditches behind the 5th & 11th greens and to left hand side of the 13th green are lateral penalty areas (red). All other ditches and drainage channels are non-lateral penalty areas (yellow).

Obstructions

The obstructions on the course are the clubhouse and paths around it, shelter sheds, manmade paths excluding bridges, cable house and telegraph pole at 16th green. If telegraph pole struck while playing 17th hole, should be retaken without penalty.

Sprinkler Heads

All sprinkler heads are immovable obstructions and relief from them may be obtained under **Rule 16.1**.

In addition, a player may take relief if the sprinkler head lies in a direct line between the hole and the ball and the ball lies within 1 club length of the sprinkler head.

In these circumstances the ball may be lifted and dropped at the nearest point to where the ball lay which: **a.** is not nearer the hole; **b.** avoids interference with the sprinkler head; **c.** is not on putting green.

Local Rule D-4

If a player must take relief under **Rule 13.1f** because his or her ball came to rest on the wrong putting green of which is defined to include area of fairway within two club lengths of that putting green or interferes with his or her stance or area of intended swing:

In finding the relief area to be used when taking this relief, the putting green is defined to include the area of fairway within two club-lengths from the edge of the putting green.

This means that the nearest point of complete relief must avoid interference from this area in addition to the putting green.
